## General Membership Meeting Highlights

Saturday, November 26, 2016 at the US Open

Co-founders and Chairmen Annie Hirsch and Skippy Blair have taken on Emeritus status on the WSDC board. They will continue to be available as consultants to the Council but the daily operations of the organization shall be the responsibility of the Executive Board of Directors.

There was a beautiful presentation made to Annie and Skippy on Saturday night with a video highlighting their achievements.

Dani Canziani is the new President of the WSDC. Two additional board members were elected. Jim Coakley and Demery Leyva. Bios of the new board members may be found on our website.

Mark Scheuffele, the WSDC Treasurer, reviewed the current balance sheet and Profit statement. The organization remains in good standing as a 501(c)3. We are working to increase the platforms for national and international online payments. We have hired a new bookkeeper to improve accounting administration and payment

processing. Using Intuit Quickbooks, WSDC will send out membership invoices with the ability to pay with a Credit Card or Bank Transfer. The invoices and payment options will be in the currency of the Professional Members country of residence. As of January 1<sup>st</sup>, 2017, the fee on all future electronic payments will be free. This includes PayPal, Bank Transfers and Credit Card fee's made through the authorized online processes.

#### ROLLING MEMBERSHIP:

In the past we have had a set date in the Summer for all renewals of membership. Going forward, we will have a rolling membership. An invoice will be sent approximately 30 days prior to the event, and will be due 30 days after the event. Giving the Professional Members a 60-day payment window. This will increase accuracy of the registry and balance the workload for our administrators so that payments are processed timely and calendar updates are made at a

The WSDC would like to remind all Registry Events to use "WSDC" as a heading to those divisions recorded in the Registry. This is to help clarify for all competitors that this contest will be submitted for points. An example for your website, schedule, promotions could be:

WSDC Novice Jack & Jill  
WSDC Intermediate Jack & Jill  
WSDC Advanced Jack & Jill  
WSDC All Star Jack & Jill  
WSDC Champions (or Invitational, etc.) Jack & Jill

Any divisions without the WSDC heading would specifically indicate a contest that is not a Registry

recorded division; such as

All American Jack & Jill  
Certain Invitational Contests  
Bookends Jack & Jill, etc.

Each competitor may enter only one (1) WSDC skill level Jack and Jill. Each competitor may enter only one (1) age level appropriate WSDC Jack & Jill.

A dancer can dance in a WSDC division and a contest that does not submit points to the registry.

time when most event directors can forecast the future dates for their event.

The transition to the new rolling membership process is now being implemented. There will be a year in which partial payments will be due; as most members have a credit through June 2017. Beginning in 2018 the new rolling membership should be fully implemented.

The WSDC is working on cleaning up documents that

are on the website to create clarity and consistency. We will be updating the documents to include a Penalty Level Chart which will describe levels of infractions and the associated fines for each type of infraction.

Two Registry Member Event Directors, in attendance at the General Meeting, asked the board to meet to revisit a decision related to an infraction that occurred at their events in 2016. The board had a conference call on November 30, 2016 and concurred that a rule had been broken, but that the event directors involved did not have malicious intent and that the infraction was due to neglect. The fines imposed were reduced, letters were sent to the Registry Members involved and their Events are in good Standing.

Our next General Membership Meeting is scheduled for Mid 2017. The event location has not been determined, but we are looking to have a meeting somewhere on the East Coast.
